## 02 Product How to

How to enroll cards with master card

#### Preparation:

DS-KV8113-WTE1(C) / DS-KV6113-WTE1/ KD8003-IME1 door station Mifare cards/tags (ICS50/ DS-K7M102-M)

Step 1. Enable enrollment process

Master card is part of door station equipment.

Present master card once at reader. You will hear "beep, beep".



#### Step 2. Add cards/tag

Present all the cards/tags to the reader one by one. Each successful attempt will be confirmed with a confirmation "beep" tone.



#### Step 3. Exit enrollment process

Present the master card again to exit recording mode. You will hear a "beep, beep" to confirm. *Note:* After 15 s without any action, the intercom station automatically exits enrollment process.

#### Step 4. Test

Present all user cards and check if they can open the door. Successful authorization is required.

How to cancel door open time for turnstile application

#### Preparation

DS-K2602T controller version 1.1.1 build 231108 and above

Software: HCP/IVMS 3rd party turnstile

#### Application scenario. Purpose

3rd party turnstile. We give a signal to the turnstile to open for 20 seconds, for example. And access through the turnstile is free. During these 20 seconds, more than one person can pass. With this logic, we use a Hall sensor (like a magnetic contact) that monitors whether the turnstile has rotated and stops access (we lock the turnstile, even if the time has not expired).


#### **How to Configuration**

Create linkage between case input 1 and the Access point. Open HCP software.

Step 1: Go to Device → Access Control Device. Select controller Remote configuration button.



Step 2: Add new Event Linkage








How to cancel door open time for turnstile application

For Event type select Alarm Input Event and Alarm Input Alarm Triggered. Source Casein 01.



Select Linkage action with Access Point. Turnstile door and Lock status.



Step 3: Save configuration.



## 03 Product Q&A

## Question 1 - Can the message-leaving function on the indoor station apply to the main station leaving messages on the indoor station?

Answer:

Not currently, only the door station can leave messages for the indoor station, and the main station cannot leave messages for the indoor station.

## Question 2 - What is the registration logic from the indoor station to the door station? Answer:

After the indoor station finishes booting, it will randomly initiate registration to the door station after 1-15 seconds.

Registration cycle is the last 2 digits of the serial number \* 6 + 600 seconds.

When the power is on, if the indoor station starts up before the door station, when the indoor station initiates registration, the door station does not start up and finish (or does not turn on) and does not give a response, it will wait for the next registration cycle before it initiates registration, which requires a random wait of 10-20 minutes according to the serial number of indoor station.

## Question 3 - What is the live view time limitation in the android indoor station internal Hik-Connect?

Answer:

It is limited by Hik-Connect, streaming limitation is only 5 minutes, and intranet direct connection or P2P is unlimited time.

#### Ouestion 4 - What does the indoor station 10200 error code mean?

Answer

The connection times out, please check whether the video source is online, or the video source IP/port is correct. The error code is 10200.

Cause: the video source is not online, or the video source IP/port is wrong. Measures: Check the IP and port configuration to confirm that the video source device is normally online.

#### Question 5 - How does the KH6220-LE1 unlock 2?

Answer:

Long press the unlock button to unlock 2, short press the unlock button to unlock 1
